- 3. Validity of the bid is 90 days from the date of opening quotation.
- 4. Items should be delivered within 30 days for the date of Purchase Order.
- 5. Selected bidders are strictly prohibited for subletting the assigned work/work order.
- 6. Incomplete and conditional Quotation will not be accepted.
- 7. The Registrar, Jagat Guru Nanak Dev Punjab State Open University, Patiala reserves the right to cancel the bid without assigning any reason.

- 8. Copy of Pan Card & GSTN must be attached.
- 9. Payment shall be made in Indian rupees on Final acceptance & after verification by the specified consignees and their issue of clearance & acceptance certificates to the satisfaction of the authority.
- 10. If the material is not delivered on or before the due date the competent authority will have the right to deduct 2% of the total bill for every weeks default, no extension time will be permitted. The decision of the University shall be binding on the bidder in this regard.
- 11. TDS is applicable as per Income tax rules.
- 12. Quotations will be opened at 3:00 PM on 18.03.2025 (Tuesday) in the committee room of the University i.e. Jagat Guru Nanak Dev Punjab State Open University 28-C Lower Mall Patiala. The firm or its representative can attend the opening of the quotation.
- 13. The rates should be F.O.R. and should include excise duty, sales tax, freight charges, GST and other taxes rates in respect of the supplies. The University shall not be liable to pay any tax, freight etc. Which has not been expressly stipulated in the quotation.
- 14. All disputes, differences, claims and demands arising under or pursuant to or touching the contract shall be referred to the sole arbitrator i.e, the Registrar JGNDPSOU Patiala.
